SENATOR WARNER: Mr. President, members of the Legislature, LB 74 is a bill which was discussed somewhat a few days ago on a reference issue, but to refresh your mind, LB 74 is an amendment to a statute that was enacted a couple, three years ago. You may recall that at that time a problem had been created in areas where there was a subdivision on vacant land plotted, and as a result of that subdividing, subdivision or the creation of lots, that a school district boundary in existence could result in a lot being in two school districts, a portion of the lot in two or more school districts. The law that was enacted resolved the issue by authorizing the lot so created and lying in two school districts to pick which school district it would be attached to, and it was a reasonable solution to a relatively minor problem. Afterwards, however, a condition arose where, actually it was

within the legislative district I represent, where the Lincoln City Council created a split lot by annexing a strip of 10 feet along a road, which then resulted in a lot, not because of subdividing, but because of the annexation laws affecting Lincoln where the Lincoln School District is at least concurrent with the city's boundaries, and that is a policy decision I support, but by doing what they did, they created a split lot, and under the provisions of the law that had previously been enacted, it was conceivable then that that lot could go to a different school district because it had been split. That particular action by the Lincoln City Council was vetoed by the mayor and, subsequently, was not overridden so it is a past issue. What the bill does is clarifies existing law that if there is a house on a lot that then the property would go to the school district where the house sets, whereas, if it is a vacant lot, the lot would then go to the school district where the majority of the lot lay. I think this is... I would move that the bill be advanced. This is a relative straightforward and it still addresses and solves the issue that the law was originally enacted for without permitting the use for it to artificially create split lots which was not the intent of the original legislation. So I would move the bill be advanced.

PRESIDENT: Thank you. The question is the advancement of the bill. All those in favor vote aye, opposed nay. Record, Mr. Clerk, please.

CLERK: 31 ayes, 0 nays, Mr. President, on the advancement of LB 74.

The changes in the federal requirements permit the stat : to remove paternity matters from this expedited process. The judges and the Department of Social Services have excluded paternity because these actions don't lend themselves to the expedited process. Appointment of counsel, jury trial, discovery, blood tests, et cetera make paternity matters a poor candidate for the expedited process. LB 265 would, however, allow referees to handle paternity matters under direction of the district court. I would urge the adoption of the amendment.

SPEAKER BARRETT: Any discussion on the amendment to 265? If not, those in favor of the adoption of that amendment please vote aye, opposed nay. Voting on the amendment to LB 265. Please vote, if you'd care to vote. On the amendment to 265, please vote, if you'd care to vote. Record, please.
