Mr. President, 780 is on General File. It was a bill introduced by the General Affairs Committee and signed by (Title read.) The bill was introduced on January 19, referred to the General Affairs Committee. The bill was advanced to General File.

SPEAKER BARRETT: Madam Chair, Senator Smith.

SENATOR SMITH: Thank you, Mr. Speaker, members of the body, LB 780 is a bill that was brought to General Affairs Committee by the Liquor Control Commission and, basically, all it is, is just technical changes in the Liquor Control Act and proposed by that commission. It removes such things as an obsolete loyalty oath, a requirement that shippers obtain surety bond because all retailers were removed last year; removes obsolete language relating to revenue stamps that are no longer even being required; changes the word "secretary" to "executive director" in commission statutes and removes the formula by which beer must be made from law and removes other obsolete references such as that. There are not any substantive changes that will be made in the law based on these changes in this bill. We ask the support of the bill. If there are questions, I will try to answer them. Thank you.

CLERK: Senator, you had an amendment that I understand you would like to withdraw?

SENATOR SMITH: We would like to have that drawn, or pulled.

SPEAKER BARRETT: It is withdrawn.

CLERK: I have nothing on the bill, Mr. President.

SPEAKER BARRETT: Any discussion on the advancement of LB 780? Any questions, any discussion? Senator Smith, any closing statement?

SENATOR SMITH: We would just ask for the body to support the moving of the bill.

SPEAKER BARRETT: Thank you. Those in favor of the advancement

of LB 780 to E & R Initial please vote aye, opposed nay. Have you all voted? Record, please.

CLERK: Mr. President, LB 95 was a bill introduced by Senator (Title read.) The bill was introduced on January 5, referred to the Urban Affairs Committee. The bill was advanced General File. I have committee amendments pending by the Urban Affairs Committee, Mr. President.

SPEAKER BARRETT: Senator Hartnett.

SENATOR HARTNETT: Mr. Speaker and members of the body, came up faster than I thought it was. I'm having a handout passed out, but the committee amendments really become the bill and so I'll just, if I can wait, is that they...what the bill did, its original purpose had brought to the Urban Affairs Committee by Senator Landis and it was voted out of committee, with all the people who were there when we've had Exec Session, unanimously. That it...it's to (inaudible) construction of an intra, intrastate, within the state natural gas pipeline to serve Nebraska's only primary class city which is Lincoln. It relates only to Lincoln. It provides the regulation of that pipeline by the City of Lincoln and it follows what we did a few years ago, or last year, with LB 663, and what the amendments do, there is a couple of things. It allows the...place a regulation by the city into the Municipal Natural Gas Regulation and provides a framework for the regulation and the manner in which savings are passed onto customers and monitor. process would become part of the regulatory system adopted by the Legislature in LB 663 two years ago. In response to question raised at the public hearing on the bill, it seeks to clarify the intent of the Legislature that natural regulations is not within the authority or jurisdiction of the Public Service Commission. It is historically within this state natural gas regulation has been the prominence of cities and simply spells this out again that the City of Lincoln will control this. The amendment was a product of a negotiation between the Urban Affairs Committee and staff of Senator Landis's office and members of the natural gas industry, and I think that is an explanation on the amendment.

SPEAKER BARRETT: Senator Wesely, would you care to close on your challenge?

SENATOR WESELY: Thank you. Senator Rogers, we have not discussed this amendment whatsoever. I did make a motion to amend a bill, and pull a bill out of committee, and I have withdrawn those with the intent of trying to...actually I was going to try and amend Senator McFarland's bill when it was on Select File so it wouldn't give you a problem with your piece of legislation. But, unfortunately, his bill didn't proceed and yours did. I'm not... I think it's a legitimate issue and it does cover both the act. It is a different purpose, but why can't we understand that there is a melting of these issues. If we're, on the one hand, trying to expand the credits and increase the credits, isn't it fair to ask that we can't consider, at least consider an amendment to increase the accountability and disclosure of those credits? I think it all ties in together, and I would ask your support to overrule the germaneness ruling of the Chair.

SPEAKER BARRETT: Thank you. The question is, shall the Chair be overruled? Those in favor vote aye, opposed nay. A majority of those present required to overrule. In this case the magic number is 21. Have you all voted? Have you all voted? Record, Mr. Clerk.

Therefore, delivery in person would now be statutorily allowed. So it just allows some options for the city. With that, I would ask for this amendment to be attached to the bill.
