CLERK: Mr. President, the next amendment I have to the bill is by Senator Kristensen.

SPEAKER BARRETT: Senator Kristensen, please.

SENATOR KRISTENSEN: Thank you, Mr. Speaker. The amendment which I have is one that has received a considerable amount of discussion this afternoon from a variety of people to myself and from a variety of people in the Rotunda, and this amendment deals with putting \$18 million directly into state aid for education. I'm very serious about this amendment, however, I'm not sure that now is the time or the place to do that, and I believe it's important to move this budget bill along. There's another vehicle that I may look at to put this amendment there and so, in that spirit, to move this along, I would pull this amendment with the sincerity that the amendment is valid and I believe has some very good points and one that needs to be discussed before this session is over. But I will pull it at the time, thank you.

SPEAKER BARRETT: Thank you, Senator Kristensen. It is withdrawn.

CLERK: I have nothing further on the bill, Mr. President.

SPEAKER BARRETT: Thank you. Senator Warner.

SENATOR WARNER: Mr. President, I move that LB 813 be advanced.

SPEAKER BARRETT: Any discussion? Senator Moore? Thank you. Shall LB 813 be advanced? Those in favor say aye. Opposed no. Carried. The bill is advanced. Anything for the record before we go to LB 814, Mr. Clerk?

CLERK: Mr. President, I have one item. I have an A bill, LB 815A by Senator Smith. It's a bill for an act to appropriate funds to implement LB 815. That's all that I have, Mr. President.

SPEAKER BARRETT: Thank you. Moving then to LE 814.

appropriation. We'll be splitting some of those costs for reestablishing that survey. But we want to put it forth in front of you so it's available. We're not sure when and we're not intending to put it in at this time.

SPEAKER BARRETT: Any other discussion? Anything further, Senator Conway? The question is then the advancement of 817A. Those in favor vote aye, opposed nay. Record, please.

SPEAKER BARRETT: LB 817A is advanced. With your permission I'd like to address one more A bill which is now ready, 815, LB 815A.

SPEAKER BARRETT: Senator Smith, please.

SENATOR SMITH: Thank you, Mr. Speaker. Members of the body, this is simply the appropriation of funds from the Charitable Gaming Operations Fund to the Petty Cash Fund that I discussed in the amendment that I had this morning. I would ask for your vote of support for this.

SPEAKER BARRETT: Is there discussion? Seeing none, those in favor of the advancement of LB 815A please vote aye, opposed nay. Please record.

Senator Lynch and Bernard-Stevens then have moved, Mr. President, to reconsider the vote on the Kristensen amendment. That motion is now pending.

SPEAKER BARRETT: Back to the motion to reconsider. Senator Lynch, will you handle the reconsideration motion?

SENATOR LYNCH: Yes, Mr. President, thank you, and members, I, immediately, when I walked in this morning walked in on a conversation dealing with 89 because of the amendment to 525 and I'm grateful for all those good words that were mentioned like, you know, they don't want to kill LB 89, they don't mean to hurt 89 and I think 89 has enough votes to go anyhow, but I'm not sure of any of those things so I rise to talk about my amendment to reconsider with mixed emotions. I just would mention a couple of things so you understand. When we talk about aid to education, I know back in '86-87 it was 125 million and then it was dropped in '87-88 to 122, but it jumped back up to 133 million in '88-89. There looks like the request is fairly constant at that number. However, there is an increase, substantial increase in special education money of about \$4 million requested. I'm not quite sure how that will work out. It depends on how you think and consider this kind of a compromise and a trade-off in a sense. I can't tell you what is
