members, and it makes it totally unworkable for them when they have anyone absent. It takes everyone present to be able to vote to make anything move or to approve an ordinance, for instance. So what LB 966 does is to decrease the number of votes from a two-thirds majority, which is presently the way the law reads, and that comes out to be a 3.3 percent council members, and make it become instead a three-fifths majority vote. And I would ask, on behalf of Senator Wehrbein, that you would approve this piece of legislation and move it along. Thank you.

PRESIDENT: Thank you. If there is no further discussion, the question is the advancement of the bill. All those in favor vote aye, opposed nay. Record, Mr. Clerk, please.

ASSISTANT CLERK: 25 ayes, 0 nays on the advancement of the bill, Mr. President.

PRESIDENT: LB 964 (sic) advances, that was LB 966, excuse me. LB 997, please.

ASSISTANT CLERK: LB 997 was introduced by Senator Schellpeper. (Read title.) The bill was read for the first time on January 4th of this year, was referred to the Health and Human Services Committee. They report the bill back to General File, Mr. President.

PRESIDENT: Senator Schellpeper, please.

SENATOR SCHELLPEPER: Thank you, Mr. President and members. LB 997 extends the Rural Health Manpower for one year. It's been in operation since 1977, and it has had several extensions before, and this will extend it for one more year. This commission is what they use to put the rural doctors in the rural areas. And so it's very important to Nebraska. I would just move for the adoption. Thank you.

PRESIDENT: Thank you. If there's no further discussion, the question is the advancement of the bill. All those in favor vote aye, opposed nay. Record, Mr. Clerk, please.

ASSISTANT CLERK: 25 ayes, 0 nays on the advancement of the bill.

PRESIDENT: LB 997 advances. LB 857, please.

ASSISTANT CLERK: LB 857 was introduced by Senator Withem. (Read title.) The bill was read for the first time on January 3rd, was referred to the Government Committee, which reports the bill to General File.

PRESIDENT: Senator Withem, please.

SENATOR WITHEM: This is a bill that was brought to me by a constituent in my district who belongs to the organization known as the Paralyzed Veterans of America. Paralyzed Veterans of America is a recognized veterans organization, and there is a statutory definition of what it means to be a recognized veteran's organization. And being a recognized veterans organization allows them to participate with our veterans department in the state in administering veterans benefits. As I say, there is a definition in the statute of what it is. It's one that is chartered by Congress, has a state headquarters, and has enrolled in its membership in Nebraska at least 10 percent of the World War I, World War II, Korean and Vietnam War veterans. The Paralyzed Veterans of America has only recently become a recognized veterans organization. And when they went to the veterans council in Nebraska they found there was really no mechanism to provide this new recognition. So what this bill does is it simply places in statute those four organizations that meet this criteria that is in our statutes for being recognized. Those four are the American Legion, the Disabled American Veterans, the Veterans of Foreign Wars the United States and the Paralyzed Veterans of America. I would urge you to support the bill.

PRESIDENT: Senator Schellpeper, please.

SENATOR SCHELLPEPER: Thank you, Mr. Speaker. I just wanted to say that this is Withem's bill and not mine. I would take credit for it, because it isn't that bad of a bill. But it's not my bill. Thank you.

PRESIDENT: Did you wish to close, Senator Withem?

SENATOR WITHEM: I would agree wholeheartedly with Senator Schellpeper, that even though the board says otherwise, this is not his bill. But, if he'd like it, he could have it. I would be happy to let him add his name and take my name off of it, if that were his desire. I would urge you to support the bill.

Do I have to have 30 votes on this advancement, or in the end? What do you mean no?

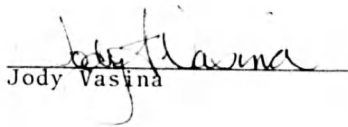

LB 855 is identical with the animal damage control bill that we passed through Final Reading and sent to the Governor last year and was a casualty in the funding crisis that we had sent to her desk. This particular program is one that is supported by the USDA Department of Agriculture, animal damage control people, that assist with funds to the state in controlling animals that are a nuisance and are predatory animals. Several western counties have been funding local programs in their counties independently of the state and receiving federal aid in their efforts. The livestock, sheep, poultry industry in the state are very interested in this bill. We heard it in Agriculture Committee January 23. We had nine different persons representing themselves and different agencies and units, such as the Nebraska Animal Damage Control Board of the USDA, Nebraska Farm Bureau, the Game and Parks Commission,
