SPEAKER BARRETT PRESIDING

SPEAKER BARRETT: Thank you. Proceeding to the next item on...from the Rules Committee. Chairman Lynch.

SENATOR LYNCH: Mr. President, members, the next one is number nine identified on your list. It specifies that a motion to suspend the rules is not divisible. The reason for this, without reading it all but putting it hopefully in laymen's terms so we can understand it, is that when a motion to suspend the rules is attempted it's intended to accomplish only one thing. You don't suspend the rules to accomplish three, four, five or six different things. But, if the amendment that would accomplish one thing would, for example, suspend Rule 1, Section 2, Rule 2, Section 3, Rule 3, Section 4, because it's necessary to do that to identify those sections of the rules that serve that single purpose, you cannot divide the question and take any one of those three rule changes independently. I think, Mr. President and members, that explains the purpose and intent of this rule change and would suggest that we support it.

SPEAKER BARRETT: Thank you, Senator Lynch. Discussion on the proposal...proposed change number nine? Senator Chambers, please.

SENATOR CHAMBERS: Mr. Chairman and members of the Legislature, let me tell you what the real purpose of this rule change is. There have been attempts at various times to suspend the rules so that there can be no debate or discussion or amendment on bills, and I have indicated that I would divide that question. So the purpose of the rule is to prevent that from happening. So however many things are put into a rule suspension will have to be taken as a package. In some instances you may have a situation where people will think and believe that you should be able to suspend the rules for the purpose of taking a vote without any additional debate, amendment and so forth. And maybe that is all right. Naturally, I'm opposed to it because

PRESIDENT: The bill is advanced. LB 893, please.

ASSISTANT CLERK: LB 893 was introduced by Senator Lynch. (Read title.) The bill was read for the first time on January 3rd, was referred to the Government Committee, which reports the bill to General File, Mr. President.

PRESIDENT: Thank you. Senator Lynch, please.

SENATOR LYNCH: Yes, Mr. President, members, this bill was brought to me by thousands of under-reimbursed county officials. (Laughter.) Thought I'd create a little excitement on the floor here. But I lie. I think there was one or two that mentioned it to me. What it...seriously what it does, the IRA, in case you're not concerned that's the Internal Revenue Service, has increased from whatever it was to 25.5 cents a mile their reimbursement. This provides that for county officials only, only county officials across the State of Nebraska, in the metropolitan and greater Nebraska areas (laugh) reimbursement to 24.5 cents a mile. I'd ask for your consideration and support.

PRESIDENT: Any further discussion? If not, the question is the advancement of the bill. All those in favor vote aye, opposed nay. Record, Mr. Clerk, please.

ASSISTANT CLERK: 25 ayes, 0 nays on the advancement of the bill.

PRESIDENT: The bill is advanced. LB 918, please.

ASSISTANT CLERK: LB 918 was introduced by Senator Hannibal and a number of other members. (Read title.) The bill was read for the first time on January 3rd, was referred to the Government Committee, which reports the bill back to General File, Mr. President.

PRESIDENT: Senator Coordsen, please. Senator Hannibal, excuse me.

SENATOR HANNIBAL: Thank you, Mr. President, members of the Legislature. LB 918 is a fairly simple bill. Has a substantial change in the...in law that allows for our rural and suburban fire districts that have been traditionally called volunteer, we're changing statutes to allow them to have paid employees as

well as volunteer employees. Was brought to me by the Millard Suburban Fire District because of a lawsuit that was brought against them that challenged the existing statutes, and at the very least we found a lot of ambiguities in the statute as to whether you could, indeed, pay or not pay volunteer fire department employees or volunteers. The E clause has been attached to the bill. Because of the lawsuit there is a temporary restraining situation going on in the Millard area. This does affect the entire state. If you look at the committee statement, you'll see that we had wide support from all across the state from volunteers and fire fighters in general. One final thing that the bill does do is add that...developed the rescue as well as fire protection, rescue protection statutes are changed to allow for paid employees there as well. One final thing I'd like to say is that there was some concern in hearing by some of the proponents that were talking about the bill in support of the bill, but they were in, some ways, implying that maybe volunteer fire departments weren't doing a very good job, and that was never the intent of the bill, or that they weren't doing an adequate job. That wasn't the intent. I'd like to say for the record that the volunteer fire districts have been a very, very valuable service for the State of Nebraska and continues to be. This just augments it a little further and allows some districts, if they wish, to have a combination of volunteer and paid fire fighters. I would move for the advancement of LB 918.

PRESIDENT: Thank you. Senator Schellpeper, please.

SENATOR SCHELLPEPER: Thank you, Mr. President and members. I'd like to ask Senator Hannibal a question.

PRESIDENT: Senator Hannibal, will you respond, please.

SENATOR HANNIBAL: Yes.

SENATOR SCHELLPEPER: Does this bill make it so that they have to pay, or is it voluntary if they want to pay the small rural fire departments?

SENATOR HANNIBAL: This is a permissive bill, allows for you to have all volunteers, all paid, or a combination.

SENATOR SCHELLPEPER: What about, are there any other benefits that they can pay?

SENATOR HANNIBAL: Excuse me?

SENATOR SCHELLPEPER: Are there any other benefits that they could pay as far as the insurance for firemen and things like that?

SENATOR HANNIBAL: Well, yes. As a paid employee of a fire district, and you would be entitled to look at all areas of reimbursements, including those kinds of benefits.

SENATOR SCHELLPEPER: So, in other words, this could be expanded quite a ways, Senator.

SENATOR HANNIBAL: Essentially it could. We have been assured that the implications for liability are not there. But it essentially could be expanded so that you could continue to develop into a larger and a fully paid fire service, but this will all be it, this is all permissive as opposed to mandatory.

SENATOR SCHELLPEPER: Thank you.

PRESIDENT: Did you wish a closing, Senator Hannibal? Okay. If there is no further discussion, the question is the advancement of the bill. All those in favor vote aye, opposed nay. Record, Mr. Clerk.

ASSISTANT CLERK: 27 ayes, 0 nays, on the advancement of the bill, Mr. President.
