CLERK: Mr. President, 834 was a bill introduced by Senator Haberman. (Read title.) Introduced on January 3 of this year, referred to the Retirement Systems Committee, advanced to General File. I have no amendments to the bill.

SPEAKER BARRETT: The Chair recognizes Senator Haberman.

SENATOR HABERMAN: Mr. President, members of the body, as it stands now a state employee, to join the State Retirement System, must be 25 years old with 12 months of service. So we take a young person that yets out of high school, they're 18. Possibly they don't care to go on to college, but they're good with computers, they're good secretaries, they want to go down to the local district office of the state highway patrol, get a job. So this young person gets a job at 18 and then they have to wait seven years before they can join the retirement system. I think that's wrong. Let's take a young person, they get out of high school at 18, they go to a tech school, they pick up a skill there, whatever it might be, mechanics or drawing or architecture, whatever it is, they go to work for the State of Nebraska at 20-years-old and they have to wait five years before they can join the retirement system. I think that's wrong. Let's take someone that goes to college. When they get out of college they are 22-years-old. They want to go to work for the State of Nebraska. They get the job, then they find out they have to wait three years before they can join the retirement system. I feel, and I know you feel that that is wrong also. Now we want to keep the young people in Nebraska, yet we are penalizing them, we penalize them when they want to go to work for the State of Nebraska, be it highways, social services, Department of Agriculture, Correctional Services, Department of Education, Health Department or what have you. So the bill simply changes the 25 years age to 20 years, then they can voluntarily join after they have worked for the state for 12 months. I ask for the passage of LB 834, Mr. President.

SPEAKER BARRETT: Thank you. Discussion? Questions? If not, those in favor of the advancement of LB 834 to E & R please vote aye, opposed nay. Record, Mr. Clerk.

CLERK: 26 ayes, 0 nays, Mr. President, on the advancement of LB 834.

SPEAKER BARRETT: LB 834 advances. Proceeding then to LB 987.

CLERK: 987, Mr. President, clered by Senator Schmit. (Read title.) The bill was introduced on January 4 of this year, referred to Natural Resources. The bill was advanced to General File. I have no amendments to the bill, Mr. President.

SPEAKER BARRETT: The Chair recognizes Senator Schmit.

SENATOR SCHMIT: Mr. President and members, this bill establishes the State Government Recycling Management Act. It is designed to deal with state government refuse and the most energy and resource secting manner. It is going to transfer from the Department of Administrative Services to the State Energy Office that responsibility and the purpose of the proposal is to encourage the recycling of government materials which...such as paper, paperboard, aluminum, metals, et cetera, little glass and so forth that does accumulate within the area of state government. It is a low budget item of about \$36,000 A bill I believe, and any money that is earned from the collection and sale of this, of these resources are to be credited to the General Fund. Any other questions, I'd be glad to try to answer them.

SPEAKER BARRETT: Discussion? Senator Morrissey, followed by Senator Johnson.

SENATOR MORRISSEY: Yes, thank you, Mr. Speaker, members, Senator Schmit, I support the bill. I do read there in the fiscal note, it says the State Energy Office estimates .11 FTE of their own personnel would be required to implement and oversee this act. Now the existing state coordinator will identify how it should be done and in the State Energy Office employees will administer and implement the act.

SENATOR SCHMIT: That is right, Senator Morrissey. I would assume that at the present time there is some energy being used to operate it under the Department of Administrative Services. I don't suppose there is a net energy loss or gain in the standpoint of it individual administration by the transfer, but it does provide for a little over a tenth of a person to administer that proposal in the State Energy Office.

SENATOR MORRISSEY: Okay, thank you. And then my problem was that to administer I could see the .11 and...but to identify the program it would take to identify and collect the paper, paperboard, aluminum and other metals, yard waste, glass, tires February 20, 1990 LB 987

and oil and plastic, that's what I didn't think could be done by that .11 employee and, thus, Monte McKillip (phonetic) would probably be doing that.

SENATOR SCHMIT: I really don't know who would do it, Senator.

SENATOR MORRISSEY: Okay, but it...I, again, I support the bill and I'm just trying to get a couple questions answered and I'll talk to you later on those, so we don't delay the bill. Thank you, sir.

SENATOR SCHMIT: Fine, thank you.

SPEAKER BARRETT: Thank you. Senator Johnson, please.

SENATOR R. JOHNSON: Mr. President, I'd just ask Senator Schmit a question.

SPEAKER BARRETT: Would you respond, sir?

SENATOR SCHMIT: Yes, of course.

SENATOR R. JOHNSON: Senator, does this include styrofoam products as well?

SENATOR SCHMIT: I think we exempted styrofoam because you already took care of that, Senator.

SENATOR R. JOHNSON: Okay, thank you.

SPEAKER BARRETT: Any other discussion? If not, anything further, Senator Schmit?

SENATOR SCHMIT: No, I could add Senator Rod Johnson's name to the bill if he'd like to have it added, since it's probably the major energy resource recovery act of the session, right, Senator Johnson? I move the bill be advanced, Mr. President.

SPEAKER BARRETT: You've heard the closing. Those in favor of the advancement of the bill please vote aye, opposed nay. Have you all voted? Senator Schmit, we do have an A bill. Would you handle that as well? Record, Mr. Clerk.
