SPEAKER BARRETT: Senator Haberman, on your amendment, please.

SENATOR HABERMAN: Mr. President and members of the body, I believe this is the first amendment to the budget that removes money from the budget. That is the purpose of the amendment. I would like to start out about LB 164. Now the bill says, an act relating to historic preservation; to establish a task force on historic preservation; to state intent; to provide powers and duties; and to provide for the termination of the task force. National Management Association Week has been celebrated for about the last 10 or 12 years and we have had the President and Congress authorize this week and our Nebraska chapter, which I understand, consists of about 200 or 250 Lincoln management employees asked that we participate as a Legislature.
