Education gives notice of change of hearing location regarding LB 89 as well as notice of hearing. I also have notice of hearings from the Government, Military and Veterans Affairs Committee. That is signed by Senator Baack as Chair.

Your Committee on Government, Military and Veterans Affairs whose Chair is Senator Baack to whom was referred LB 263 instructs me to report the same back to the Legislature with the recommendation it be advanced to General File. Education Committee whose Chair is Senator Withem reports LB 744 to General File, LB 183 General File with amendments, LB 264 indefinitely postponed, LB 612 indefinitely postponed. Those are signed by Senator Withem as Chair. (See pages 537-42 of the Legislative Journal.)

Business and Labor Committee whose Chair is Senator Coordsen reports LB 412 to General File with amendments. It is signed by Senator Coordsen as Chair. (See page 542 of the Legislative Journal.)

Banking Committee whose Chair is Senator Landis reports LB 61 to General File and LB 349 to General File with amendments. Those are signed by Senator Landis as Chair of the Banking Committee. (See page 542 of the Legislative Journal.)

Mr. President, in addition to those items, resolutions, LR 21 by Senators Beyer, Goodrich, and Senator Abboud asking the Legislature to express its sympathy to the family of Opal Peterson. That will be laid over, Mr. President. (See page 543 of the Legislative Journal.) LR 22 by Senator Dierks asking the Legislature to recognize July 1, 1989 as Centennial Day for the Village of Elgin. (See page 544 of the Legislative Journal.)

Mr. President, Senator Lynch would move that LB 90 be placed on General File notwithstanding the actions of the Natural Resources Committee, Mr. President. That will be laid over. (See page 543 of the Legislative Journal.)

I have amendments to be printed from Senator Schellpeper to LB 114. (See page 543 of the Legislative Journal.) That is all that I have at this time, Mr. President.

Two reports, one from the Department of Social Services regarding filing pursuant to statutory provision. I also have received, Mr. President, from the Department of Roads. There is the system map as filed pursuant to statute from the Department of Roads. That is all that I have, Mr. President.

PRESIDENT: We'll move on to number five, the legislative resolutions. The first one is LR 21, Mr. Clerk.

CLERK: Mr. President, LR 21 offered by Senators Beyer, Goodrich, Abboud and Hefner. (Read LR 21.) The resolution, Mr. President, is on page 543 of the Journal.

PRESIDENT: Senator Emil Beyer, please.

SENATOR BEYER: Mr. Speaker and colleagues, as we all go through life we experience a situation like this at one time or another and I think it would only be proper that we present this to Senator Peterson. I would also ask unanimous consent to have all members of the Legislature's names be added to the resolution. Thank you.

PRESIDENT: Thank you. Senator Beyer, we'll add everybody's name unless they request that their name not be put on it, so... All right. The question is the adoption of the Beyer resolution. All in favor vote aye, opposed nay. Have you all voted? Record, Mr. Clerk, please.

CLERK: 26 ayes, 0 nays, Mr. President, on adoption of LR 21.

PRESIDENT: The resolution is adopted. LR 22, Mr. Clerk.

CLERK: Mr. President, LR 22 offered by Senator Dierks, found on page 544 of the Journal, asking the Legislature to recognize Elgin Centennial Day which is scheduled for July 1, 1989.

PRESIDENT: Senator Dierks, please.

SENATOR DIERKS: Thank you, Mr. President and members of the body. Mr. Clerk, are there any amendments on this resolution?

CLERK: No, sir.

SENATOR DIERKS: That's a relief. You can't imagine my relief

at that, I...I'm very pleased to bring this resolution to the body. Elgin is in my district and has been the home of many, many fine leaders of our state. Some of the people who have come from Elgin are former Governor Val Peterson. He had been a superintendent of schools at Elgin; Mr. Louis Lehr who rose to the chairman of the...or Chief Executive Officer of 3M Company in Minneapolis and Senator Bill Wylie who many of you know, his father, Matt Wylie, his mother all had been senators in this body. I think it is only fitting that we go ahead and honor this community on their centennial and I urge that we vote the resolution and send this copy to the city council in Elgin. Thank you.

PRESIDENT: Thank you. Senator Hartnett, please.

SENATOR HARTNETT: Mr. President and members of the body, I simply stand here to also recognize Elgin because when I was a young man and starting out on my teaching career, the first game of six-man football I ever saw in my life, I was one of the coaches and I was playing against Elgin and we won the game not because of the great coaching ability, but we won the game and we beat Elgin so I want to...I remember that yet to this day, so it was a very poignant moment in my life, so thank you. The score was 19 to 18.

PRESIDENT: Senator Hartnett, is that the one where you played eight man and the other team had six men?

SENATOR HARTNETT: No, we were both...that was my first game that I have ever saw a six-man football game in my life and I was one of the coaches.

PRESIDENT: Okay, thank you. Senator Schimek, please.

SENATOR SCHIMEK: Mr. Chairman and members of the body, I would be remiss, I'm sure, if I did not stand in support of this motion because my husband's father grew up in Elgin, so I would recommend passage of this resolution.

PRESIDENT: Thank you. The question is the adoption of the Dierks' motion. All those in favor vote aye, opposed nay. Have you all voted? Record, Mr. Clerk, please.

CLERK: 30 ayes, 0 nays, Mr. President, on the adoption of LR 22.

CLERK: (Read record vote. See page 558 of the Legislative Journal.) 43 ayes, 0 nays, 1 present and not voting, 5 excused and not voting, Mr. President.

PRESIDENT: LB 34 passes. While the Legislature is in session and capable of transacting business, I propose to sign and do sign LB 34 and LB 33. Do you have something for the record, Mr. Clerk?

CLERK: Mr. President, I do.
