CLERK: Mr. President, items for the record, amendments to be printed to LB 1064 by Senator Withem; Senator Schmit to LB 1031; Senator Crosby to LB 1153. (See pages 1366-68 of the Legislative Journal.)

Mr. President, new resolutions, LR 292 by Senators Rogers, Dierks, Wehrbein, and Schellpeper calls for an interim study. LB 293 by Senator Schmit asks the Legislature to congratulate the Wahoo High School boys' basketball team. And, Mr. President, a new A bill, LB 1222A by Senator Hartnett. (Read for the first time by title.) And I have amendments to LR 239CA by Senator Schimek to be printed. (See pages 1368-70 of the Legislative Journal.)

PRESIDENT NICHOL PRESIDING

PASTOR FRED TEDDER: (Prayer offered.)

PRESIDENT: Thank you, Pastor Tedder, we appreciate your service this morning and we welcome you and your wife to stay with us as long as you desire. Thank you again. Roll call, please.

CLERK: I have a quorum present, Mr. President.

PRESIDENT: Thank you. Any corrections this morning?

CLERK: Mr. President, I do. (Read corrections to the Journal. See page 1393 of the Legislative Journal.) That's all that I have, Mr. President.

PRESIDENT: Thank you. Any messages, reports or announcements?

CLERK: Mr. President, I have received the lobby report for the week of March 12 through March 16 which is required by statute. That will be inserted in the Journal. Received two reports, one from the Department of Revenue pursuant to law regarding LB 775 and a 1989 annual report of the Nebraska Intergovernmental Data Communications Advisory Council. Those will be on file in my office, Mr. President. That's all that I have.

PRESIDENT: While the Legislature is in session and capable of transacting business, I propose to sign and do sign LR 281. (See page 1394 of the Legislative Journal.) Move on to the resolutions, please, LR 293.

CLEFK: LR 293 was a resolution introduced by Senator Schmit. It is found on page 1369 of the Journal. (Read brief description of the resolution.)

PRESIDENT: Senator Schmit, please.

SENATOR SCHMIT: Mr. President and members, as you know this is the third year in a row that Wahoo High School basketball team has been state champion in the Class B division. They have shown the degree of sportsmanship and cooperation and teamwork that is necessary to repeat not once, but twice, in this prestigious honor and all of us in the area and in Nebraska, of course, are proud that in this day when sometimes we find things wrong with young people, that we can commend those who perform March 16, 1990 LR 293, 297

well and above average. I can't help but say a word or two also for the young lads that Senator Wesely did yesterday, all the rest of them who competed who did not win. The sportsmanship is important and it's a part of the learning process and I ask for support of the resolution.

PRESIDENT: Thank you. The question is the adoption of the resolution. All in favor vote aye, opposed nay. Record, Mr. Clerk, please.

CLERK: 24 ayes, O nays, Mr. President, on adoption of LR 293.

PRESIDENT: The resolution is adopted. LR 297, please.

CLERK: Mr. President, 297 was introduced by Senator Haberman. It is found on page 1383 of the Journal. (Read brief description of the resolution.)

PRESIDENT: Senator Haberman, please.

SENATOR HABERMAN: Mr. President and members of the body, I'm very pleased this morning that Wahoo did not have the opportunity to play the Perkins County High School at Grant, Nebraska, because they would not have been undefeated at the end of the year because the Perkins County High School basketball team would have defeated the Wahoo basketball team and then Senator Schmit could not have stood before this body and said those beautiful words. However, to prove this point, for the past two years the Perkins County High School Plainsmen have won the Class C state football championship, Senator Schmit, and the last two years they have won the Class C-2 basketball championship, so that's four championships in two years. Now this displays their effort and their teamwork, their skill, their spirit, their sportsmanship and, therefore, I ask this body to heartily endorse this legislative resolution for the Perkins County High School Plainsmen, otherwise known as Grant, Nebraska. Thank you, Mr. President.

CLERK : 28 ayes, O nays, Mr. President, on the appointment confirmation of Mr. Lance Paulsen.

PRESIDENT: It is accepted. The next confirmation report.

CLERK: Mr. President, Senator Schmit has a report, found on page 1385 of the Journal. Senator, it's my understanding you'd like to vote on Mr. Richard Lichti.
