CLERK: I have a quorum present, Mr. President.

PRESIDENT: Thank you. Do you have anything for the record, Mr. Clerk?

CLERK: I do, Mr. President. New resolutions. (Read brief summary of LR 397-400. See pages 1629-31 of the Legislative Journal.) That's all that I have, Mr. President.

PRESIDENT: If I could have your attention a minute, Senator Labeledz has a group of students in the south balcony. There are 57 fourth and fifth graders from Holy Ghost School in Omaha accompanied by their teacher. Would you students and teacher please stand so we may recognize you. You're a nice looking group and we're happy to have you here today. You may be interested to know that the Legislature, in a moment or two, will be talking about bingo and what the state has to do with

PRESIDENT NICHOL PRESIDING

PRESIDENT: (Microphone not activated immediately.) ...Norris Legislative Chamber. We have with us this morning our own Harland Johnson for the invocation. Would you please rise.

HARLAND JOHNSON: (Prayer offered.)

PRESIDENT: Thank you, Mr. Johnson, we appreciate it. We're ready for our morning invocation. We have with us this morning Pastor J. Andrew Thompson of the Corinth Memorial Baptist Church in Omaha, which is in Senator Lynch's district. Would you please rise for the invocation.

PASTOR THOMPSON: (Prayer offered.)

PRESIDENT: Pastor Thompson, thank you for your invocation this morning, we appreciate it. Please come back and visit us again some time.

CLERK: I have a quorum present, Mr. President.

PRESIDENT: Thank you. Do you have any corrections to the Journal this morning?

CLERK: Mr. President, one small one. On page 1623, line 24, strike "bill" and insert "resolution". That's all that I have.

PRESIDENT: Well, it's good to get that corrected. Do you have any messages, reports or announcements?

CLERK: Mr. President, a report from the Office of Risk Management. That report will be on file in my office for legislators review, if they are so inclined. Mr. President, Business and Labor, notice of cancellation of hearing. That's signed by Senator Coordsen as Chair of the committee. That's all that I have, Mr. President.

PRESIDENT: Very good. Let's move on to Senator Dierks' first resolution, LR 398.

CLERK: Mr. President, 398, offered by Senator Dierks, is found on page 1630 of the Journal. It asks the Legislature to congratulate the Village of Butte on its centennial celebration.

PRESIDENT: Senator Dierks, please.

SENATOR DIERKS: Thank you, Mr. President and members of the body. I'm pleased to bring you today this resolution that honors Butte, Nebraska, on its 100th anniversary. There will be a celebration there this summer, I'm not sure of the dates yet, but this village has been in existence for 100 years, and it's in the County of Boyd, northern most county of my district, neighbor of South Dakota. And I would just urge your support of this resolution. Thank you.

PRESIDENT: The question is the adoption of the resolution. All in favor vote aye, opposed nay. Record, Mr. Clerk, please.

CLERK: 19 ayes, 0 nays, Mr. President, on adoption of LR 398.

PRESIDENT: The resolution is adopted. LR 399.

CLERK: Mr. President, 399, offered by Senators Dierks and Hartnett, is found on page 1630, congratulates the Village of Brunswick on its centennial celebration.

PRESIDENT: Senator Dierks, please.

SENATOR DIERKS: Thank you, Mr. President and members of the body. Again, I'm very pleased to bring you another resolution that honors another village in my district, the Village of Brunswick, formerly named Chicago, by the way, and has been in existence since 1890. It's in the northern part of Antelope County, really not too far from Plainview, in Pierce County. And I'm again pleased to tell you about their celebration which will be in June this year, and you're all, of course, welcome to come and attend. I know they're planning a big parade, and I plan on being there myself. So, I urge your signing on this resolution. Thank you.

PRESIDENT: Senator Hartnett, please.

SENATOR HARTNETT: Mr. President, members of the body, I also rise to recognize the city or the Village of Brunswick, Nebraska, because that is where I started my teaching career, in 1952. There was three years of enjoyable and a very learning experience, and the great people in Brunswick, Nebraska. So I also plan to be at the celebration this summer at Brunswick in June. So, with that, I give these words for congratulations for

haste, not only makes for waste, but it makes for foolishness. You wind up doing the opposite of what is intended. I know what Senator Pirsch's intendment was and is, but thanks to help from the Governor's Office, we are going to have bill like no bill we have ever had before. This will be a first, even for the Nebraska Legislature. I don't think even Congress has achieved what we are achieving here this afternoon. So, Senator Pirsch, this is one time I am not just saying orally that...

PRESIDENT: One minute.

SENATOR CHAMBERS: ...I am going to support the amendment, I am going to vote yes. And if I could vote yes more than once, I would vote enough times myself to make sure this amendment is added. I sure would hate to be in a position of having argued strongly for this amendment, then shamefacedly having to vote against it or pull it, so I sure hope she doesn't become like a dentist and pull it. (Laughter) Mr. Chairman, we are at that time in the session when I think it is necessary to add a little levity because this is such a serious matter that we are dealing with, and with the time being short that I have left at this point, I will stop for now.

PRESIDENT: Thank you. While the Legislature is in session and capable of transacting business, I propose to sign and do sign LR 398, LR 399, and LR 400. Senator Landis, please. Senator Pirsch, would you like to close on this part of the amendment, please?

SENATOR PIRSCH: Thank you, Mr. President. Mr. Speaker, I will try and answer some of the questions that have been going. This, of course, being dealing with the same thing, we will have more of the same subject on the other three parts of the amendment, but I do want to point out in answer to Senator Hall, we are not striking the course. That is still in the bill, if you would look. It is a Class IV misdemeanor because we are saying this is a serious crime. This is a misdemeanor crime, and it should be considered more serious than an infraction. The course will still be mandated and this isn't going to clog the courts. Less than 1 percent will go to court, and if you are caught, you are caught. It is kind of like the alcohol, but remember in the case of marijuana, if you are caught, you have \$100 fine, infraction. If you hand your joint to a friend, you committed a felony. That is far too much disparity in the severity of using marijuana and that has been the problem all
