PRESIDENT: Any messages, reports or announcements?

CLERK: Mr. President, Senator Chambers has amendments to be printed to LB 89. New A bills, LB 739A by Senator Hannibal; and LB 747A by Senator Chizek. That's all that I have, Mr. President. (Read by title for the first time. See pages 1216-17 of the Legislative Journal.)

PRESIDENT: Thank you. We'll move on to the resolutions.

CLERK: Mr. President, LR 52 is a resolution offered by Senator Morrissey. It's found on page 1138. It congratulates the Falls City Sacred Heart boys basketball team for winning the Class D-1 State Championship.

PRESIDENT: Senator Morrissey, please.

SENATOR MORRISSEY: Thank you, Mr. Speaker and members. I ask your support of this resolution. The Falls City Sacred Heart D-1 boys basketball team took their second straight championship in D-1, scoring a total of 243 points, which sets a new D-1 record.
